## C. Manager's Report

WATER LEVELS:

November 2024: 94.4' average for all four wells.

### CONSERVATION:

October 2024: 15.34%

#### DAMAGE/VANDELISM:

Scout Hall was "tagged" along with the Sterling Ranch Park.

### **DEVELOPERS:**

**Monte Vista Collections** (LGI Homes – CA, LLC) – They have failed three Bac-T tests. They are flushing and sampled again today. Once they have passed two consecutive tests, they will begin patching.

**Elmwood Estates** (Torre Reich) – Developer Agreement has been signed. Dennis Bailey will begin the groundwork.

**Hoffman Ranch** (Dan Dunkley) – Plans are still in the review process. Comments and redlines have been returned to the engineer for changes. Likely to begin groundwork in early Spring.

**Sophie Estates** (FQC, Inc.) (formerly: Heans Martin Project/Kersey Rd.) – Nothing to report.

**Issaco Estates** (Solaria Technologies Sam David) (formerly Dean Wilson) — The insurance and bond information were delivered today.

#### WELL 8/FILL LINE:

Dennis Barksdale, District Engineer will be out soon to survey soon. Send out RFP late spring or early summer.

#### VAC-CON TRUCK:

Extension at the shop is complete and the new truck will be delivered by January 1, 2025.

## TREE:

A tree at the triangle across from the office is looking bad. We had it evaluated. It's approximately 80% dead and was recommended to be removed. It will be a two day project the first week of December.

## **CITY OF TURLOCK & TID:**

Due to the recent notification of rates being significantly increased to industrial customers from the City of Turlock and all rates increasing from TID beginning January 1, 2025, it's suggested that we begin the PROP 218 process to evaluate the rates.

- B. Resolution 2024-009: Approval of the Existing 125 POP Plan

The unanimously agreed to begin the process of joining the CMFA BOLD Program that was introduced and described at the October 2024 meeting.
